*All raffles must be conducted by a single manager or operator who is a bona fide member of the organization holding the license for such raffle and may not receive any remuneration or profit for participating in the management or operation of the raffle. **A Fidelity Bond in the sum of twenty five percent (25%) of the total value of the prizes to be awarded shall be required.** The terms of the bond shall provide that notice be given in writing to the Village of Northfield, office of the Chief of Police, thirty (30) days prior to the bond's cancellation. The Village of Northfield may waive the bond requirement if a unanimous vote of the members of the governing board of the licensed organization requests such a waiver.*
