2024 Alarm User Permit and/or Renewal

Dear Alarm User:

The Village Code requires an alarm user permit and/or annual renewal. Please complete and return the enclosed application form to the Police Department along with the \$20.00 fee. Keep a completed copy to mail in the next year **if you do not have any changes.** If you have changes please submit a new form.

The fee for the violation of not having an alarm permit for an active alarm system is \$100.00 per occurrence.

Please notify your alarm company that:

- All **BURGLAR ALARMS** must be called in to **847-724-4010**
- All **FIRE ALARMS** must be called in to RED Center at **847-272-2121**

In addition, please be advised that on January 1, 2002, the following unwarranted alarm fee schedule became effective:

### **Burglar/Medical Alert/All Trouble Alarms**

\$75 for alarms 5-7;  
\$100 for alarms 8-9  
\$175 for the 10th alarm  
\$200 for 11 or more alarms

### **Fire Alarms (excluding trouble alarms)**

\$100 for alarms 3-5;  
\$200 for alarms 6-10  
\$300 for alarms 11 or more

False alarms caused by human error, power outages less than 4 hours, AT&T, animals, storms, thunder, ice, snow, and unknown causes are chargeable. Attached are provisions of the ordinance, which state the types of alarms that may be waived and the method to appeal an alarm occurrence.
