In order for us to complete your file and issue a plumbing permit, the following items listed below must be submitted:

- 1) **ILLINOIS GENERAL ASSEMBLY – HBO 930 – A letter of intent shall be included with all plumbing permit applications. The letter shall be written on the licensed plumber of record's business stationery and shall include the license holder's signature and, if the license holder is incorporated, the license holder's corporate seal. If the license holder is not incorporated, the letter must be notarized.**
- 2) Copy of your current Plumbers License (photo ID).
- 3) Copy of the State of Illinois Registration License.
- 4) Total cost of plumbing work.
- 5) Plumbing Permit application completely filled out. Must have licensed plumber/ sewer contractor signature.

The Plumbing Inspector is available for inspections Monday thru Thursday from 1:00 p.m. to 3:00 p.m. The plumbing contractor must be on site for all inspections. Please call (847) 784-3551 to schedule an inspection. A 24 hour notice is required for all inspections.

Please note: If construction will affect trees protected by the Village Tree Preservation and Protection Ordinance, an Application for a Tree Permit is required. Trees in the required front and side yard setback of single family residences are protected. Trees on the public right-of-way and all trees in non-residential, multi-family and planned development properties are protected.

All connections to the Village main line sewer shall be by WYE connection and shall attach to the pipe using a non-shear coupling (Fernco "Strong Back" or approved equal) manufactured specifically for the pipe materials being connected.
